

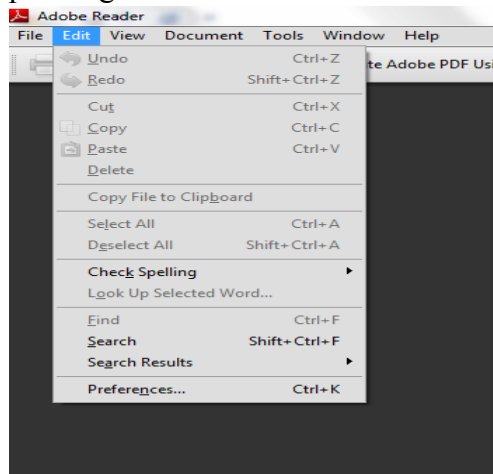

# John O'Halloran Papers SC23

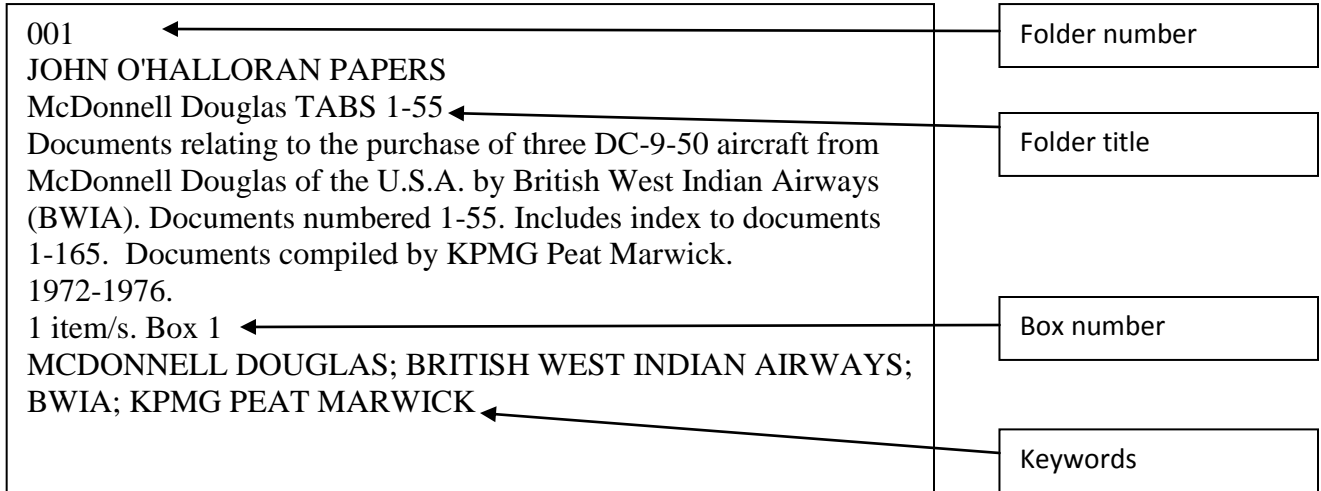
The data presented in this finding aid was extracted from an in house database created using the WINISIS software. It represents the initial sorting and current organization of the John O'Halloran Papers.
